## Be prepared Lake County

*Public input sought for  
Hazard Mitigation Plan*

**LAKE COUNTY** — The Lake County Office of Emergency Services (OES) is seeking public input for consideration in updating the countywide Hazard Mitigation Plan. According to Capt. James Bauman, Lake County Sheriff's Office public information officer.

The Hazard Mitigation Plan is the framework used by the county to optimize preparedness before disasters occur in order to reduce the damage caused by disasters when and if they occur. The Lake County OES has scheduled two public meetings to help prepare for the Hazard Mitigation Plan update as required by the California Emergency Management Agency (Cal EMA) and the Federal Emergency Management Agency (FEMA).

The public is encouraged to attend either of the two scheduled meetings and present concerns or other information about their communities or neighborhoods. The current Hazard Mitigation Plan can be viewed on the Lake County Information Portal website at [www.co.lake.ca.us](http://www.co.lake.ca.us), under Channel Menu/Be Prepared/Hazard Mitigation Plan.

The public meetings are scheduled for Jan. 20 from 10:30 a.m. to noon at the Lake County Jail dining hall located at 4913 Helbush Drive in Lakeport and Jan. 25 from 1 to 2:30 p.m. at the South Lake Fire District Station meeting room located at 21095 Highway 175 in Middletown.

Anyone wishing to contribute to the preparedness of their community and the accuracy of the Hazard Mitigation Plan update should attend one of the two public meetings. Questions may be directed to Emergency Services Coordinator Jerry Wilson at 263-1813.

## Program aims to protect the future of Clear Lake

**LAKE COUNTY** — Lake County Board of Supervisors postponed any action regarding a proposed amendment to the county's ordinance describing the quagga mussel inspection program Tuesday. Further discussion and possible action are continued to 10:30 a.m. Jan. 18.

A primary concern expressed was for multiple boat owners and/or marine rental operators that would face substantial annual fees in relation to complying with vessel inspection and sticker requirements. The item was continued to allow staff an opportunity to develop a "fleet rate" and/or maximum annual fee per address for possible inclusion in the ordinance.

run a program that is protecting the future of the lake. If the quagga mussel gets in the lake, there is no eradicating it. We are working on a program here that has pretty profound impacts," De Leon, Water Resources director said. "We all have an ownership in the protection of the lake. It's a program we all need to participate in."

Proposed amendments to the ordinance include an increase of penalty to a misdemeanor and \$1,000 fine

for entering a boat into Clear Lake that has not been properly inspected and stickered. The amendments propose an annual residential sticker and inspection rate of \$10 per vessel and elimination of non-residential bands in exchange for \$10 stickers good for a month.

Also proposed are revised definitions of resident boats to include DMV registration showing Lake County address; vessels that are moored or stored in a commercial facility in

the county; and other means deemed acceptable by the director provided the boat is on the county tax rolls.

Additionally, screening process is proposed to require visual verification that the vessel is clean and dry and that decontamination stations are to be operated by the county at no cost to the vessel owner.

De Leon said having an annual sticker program will provide a yearly opportunity to offer further and updated information to lake users and boat owners. From a cost perspective, he said, the program is pretty reasonable given that there are no ramps in the county that collect launching fees.

## Happy trails

**Master plan gets  
unanimous thumbs up**

**LAKE COUNTY** — Lake County Board of Supervisors unanimously approved the Konocti Regional Trails (KRT) Master Plan, Tuesday as well as a Negative Declaration citing no significant impacts necessitating an Environmental Impact Report (EIR).

Approval of the KRT Master Plan followed three years of development and planning that included public input and participation. Concept of the KRT system was developed in conjunction with a technical assistance grant from the National Park Service, River Trails and Conservation Assistance (NPS RTCA) program.

"I'm overwhelmed by the extraordinary body of work this project represents," District 3 Supervisor Denise Rushing said. "I think it is something everybody really wants to see for our community."

Public Works Director Kim Clymire said the plan was developed sensitive to private property without use of public domain. He said if and when the trails are built they will be on the property of willing sellers.

The KRT Master Plan is a countywide planning document for the design, development and implementation of trails for recreation and transportation in Lake County. The document attempts to lay the foundation and set the framework for the development of a network of non-motorized land-based trails and water trails that will connect communities and recreational destinations.

"I'm so glad that finally we have a plan," County Administrator Kelly Cox said. "Now we can go after funding sources."

A public survey of 15 questions issued in September 2009, which received 642 responses, helped refine the plan. According to the KRT Master Plan document, of the many topics covered in the survey, trail usage (frequency and activity type) was of particular importance. The states in terms of frequency 95 percent of respondents indicated they would use trails monthly or more often; 49 percent would use trails weekly; and 16 percent would use trails daily.

Respondents chose the following as their top three activities: walking/hiking, 87 percent; dog walking, 47 percent; paddling, 29 percent; road bicycling, 28 percent; mountain biking, 28 percent.

"Dennis is a part of our Memory Care Community and we wanted to honor his desire to dance with his wife," Evelyn Mullen, activity director said. "Because it was their 60th anniversary, it seemed like this was the sweetest time to make his dream come true."

The Hennessee's danced the night away to the sounds of "Sax-O-Rama," a saxophone quartet that recently added a rhythm section and vocalist Libbie Larson. Dancing, Leona said, was a favorite pastime she and her husband shared. "We used to dance the night away," she said. "We get through dancing at five in the morning."

23 percent; and equestrian activities, 23 percent.

Trail usage by residents and visitors is expected to assist in the stimulation of economic activity through increased direct sales of hiking, biking and kayaking equipment at the retailer level plus the resulting sales tax revenues to local and state governments. In addition, the plan states increased overnight visitation translates into increased sales at lodging and dining establishments, grocery stores and gas stations as well as other tourism-related businesses.

"Having this trail system is key to the economic development of this community," Lake County resident Carol Cole Lewis said. "I'm really excited that the county is actually stepping forward to implement this plan."

Prior to approving the KRT Master Plan and Negative Declaration, the board recognized the extraordinary efforts of volunteers Holly Harris and Chuck Lamb, whose contributions, the board said, were instrumental in the project. ## More warning signs on day of shooting

**TUCSON, Ariz. (AP)** — Investigators on Tuesday revealed more disturbing details about the events leading up to the assassination attempt against U.S. Rep. Gabrielle Giffords, including a menacing handwritten note in the suspect's home with the words "Die, bitch."

And on the day of the shooting, a mumbling Jared Loughner ran into the desert near his home after his father asked him why he was removing a black bag from the trunk of a family car, sheriff's officials said. Loughner resurfaced later Saturday when authorities say he showed up at a grocery store in a taxi and carried out the rampage that injured 14 people and killed six, including a federal judge and a 9-year-old girl.

Investigators provided the new details to The Associated Press and said they're still searching for

the bag. They suspect it could contain clues into Loughner's motives.

"The bag is very important to us," said Capt. Chris Nanos, head of the Pima County Sheriff's Department's criminal investigations division. "What was in that bag and is there any relevance?"

"What if he wrote a note that says, 'Hey, I'm going to go do these things and I know it's wrong but I'm still going to do them,'" Nanos said. "That'd be a pretty good piece of evidence."

Authorities previously said they found handwritten notes in Loughner's safe reading "I planned ahead," "My assassination" and the name "Giffords." Pima County Chief Rick Kastigar and Nanos told the AP they also found notes with the words "Die, bitch", which they believe referenced Giffords, and "Die, cops."

All the writings were either in an envelope or on an actual form letter Giffords' office sent him in 2007 after he attended one of her political events, Nanos said.

For all of it, Loughner's parents, silent and holed up in their home since the shooting spree, apologized Tuesday.

"There are no words that can possibly express how we feel," Randy and Amy Loughner wrote in a statement handed to reporters waiting outside their house. "We wish that there were, so we could make you feel better. We don't understand why this happened."

"We care very deeply about the victims and their families. We are so very sorry for their loss."

The apparent target of the attack, Giffords, 40, was able to breathe on her own Tuesday at an intensive care unit here, another hopeful sign of

her progress, doctors said.

Meanwhile, several hundred mourners filled a Tucson church for a public Mass to remember the slain and pray for the injured. As people filed in, nine young girls sang "Amazing Grace." The youngest victim of the attack, 9-year-old Christina Taylor Green, was a member of that choir.

Yvonne Ignacio, 53, went to the Mass after learning about the shooting while she was listening to a conservative talk radio Saturday.

"I am dismayed that it's become political. That's disrespectful to the victims and that's why we're here," said Ignacio, who is a tea party member.

On Wednesday, President Barack Obama will visit Arizona and give a speech honoring those killed.
